



The Measure helps recruit radical new volunteers, donors, and activists to the radical left who mislead people into thinking they are fighting against slavery. The importance of this measure is minor.

A good argument against it is that the measure is so broad it could prohibit the Department of Corrections from proper discipline and other theoretical negatives.

This has not happened in other states, including states like Tennessee, where the Republican governors have all endorsed the same Measure.

The powerful argument of abolishing slavery completely in California is something that will be used to preemptively stop this issue from radicalizing Californians who are angry about something that is minor.

For this reason, we do not care if you vote yes or no. We think it is wiser to vote YES as a preemptive vote to destroy a topic creating anger in the minority communities and among young people.




